General template requiring local legal review before use

Acknowledgment of Risk

I understand that airsoft activities involve physical exertion and known and unknown risks. These may include impacts from projectiles, collisions, uneven terrain, weather, equipment malfunction, noise, eye or dental injury, burns or fire-related risks where authorized equipment is used, and the actions of other participants. I have had the opportunity to review the event rules and Event Profile, ask questions, and decide whether to participate.

Safety Commitments

- I will follow the core rules, the Event Profile, and current Organizer or Safety Lead instructions.
- I will wear required protective equipment and will not participate while impaired by alcohol, cannabis, or other impairing substances.
- I will promptly report an injury, unsafe condition, equipment issue, or rule violation.
- I understand that the Organizer may stop play or remove me from the event for safety or conduct reasons.

Assumption of Risk and Release

To the fullest extent permitted by applicable law, I voluntarily assume the risks of participating in this event. I release and hold harmless the Organizer, venue owner or operator, event staff, volunteers, and participating landowners from claims arising from ordinary risks and ordinary negligence connected with my participation. This release does not apply where it is prohibited by law, including claims that cannot legally be waived. I understand that this language must be reviewed and adapted by local counsel before use.

Medical Authorization

If I require emergency medical assistance and cannot communicate, I authorize the Organizer or event staff to seek emergency care for me. I understand I remain responsible for costs associated with my medical care. I will disclose any condition that could materially affect safe participation to the Organizer before play.
